AN ORDINANCE ADDING SECTION 5-101(c) MOBILE FOOD VEHICLE TO CHAPTER V, ARTICLE 1 OF THE CODE OF THE CITY OF LA CYGNE, KANSAS.

NOW THEREFORE BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LA CYGNE, KANSAS:

Section 1. **That** Section 5-101(c) is hereby added to Chapter V, Article 1, of the Code of the City of La Cygne, Kansas:

## 5-101. DEFINITIONS

- (c) Mobile Food Vehicle means a self-sustained, vehicle-mounted, vehicle-towed or vehicle-carried food service establishment or mobile kitchen that engages in the sale and preparation of food or beverages to the general public. May be temporarily permitted in the parking areas of any of the commercial, industrial or public zones provided such vehicle conforms to all setback, sight distances and other applicable zoning and traffic regulations. Written authorization must be given by the property owner. An application for permit is required to be completed and filed with the City Clerk. A fee, as set in the city's fee resolution, shall be charged for each permit and shall be paid prior to issuance of the permit.
- Section 2. That any and all other ordinances in conflict with this Ordinance are hereby repealed.
- Section 3. That this Ordinance shall take effect and be in full force from and after its publication in the official city newspaper of the City of La Cygne, Kansas.

## City of La Cygne, Kansas ORDINANCE NO. 1510

AN ORDINANCE AMENDING SECTION 14-108(g) METERS, CHAPTER XIV, ARTICLE 1 OF THE CODE OF THE CITY OF LA CYGNE, KANSAS.

NOW THEREFORE BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LA CYGNE, KANSAS:

Section 1. **That** Chapter XIV, Article 1. Water of the Code of the City of La Cygne, Kansas is hereby amended by amending section 14-108(g) to read as follows:

14-108. Meters.

- (g) Customers/Owners shall be held responsible for any damage done to meters, lids, antennas, and cables servicing the account address. The city shall keep all meters in proper working condition without cost to the customer except where meter is damaged by neglect or fault of the customer/owner. Repair costs for damage due to neglect or fault of the customer(s)/owner(s) shall be charged to the customer(s)/owner(s) at the meter flat rate fee as established in the city's fee resolution, which shall be deposited to the credit of the water department fund of the city. No customer(s)/owner(s) or other person shall repair or remove any meter or break any seal on a meter, nor tamper with or interfere with the proper registration of any meter.
- Section 2. That any and all other ordinances in conflict with this Ordinance are hereby repealed.

Section 3. That this Ordinance shall take effect and be in full force from and after its publication in the official city newspaper of the City of La Cygne, Kansas.
