in so Mr. Electric could inspect it this week and they would then be ready for the meter to be put back in for Unit A. The roof and the framing are complete for the second floor. The wiring needs to be completed, drywall installed and siding. Fire Chief Nasalroad will perform a walk-thru on Monday, April 22, 2204 to review the electric work performed. Andrea Kincaid asked about a building permit for phase 3 which included the installation of egress windows in the basement. Discussion was held on the liability on the city if the home is condemned but not demolished. City Attorney advised boarding up the doors and windows on the lower level and garage and posting signs the property has been condemned as necessary measures on the city's behalf. Council Member Capp asked for the budget amount in 2024 for demolition, CC Wade stated \$10,000. City Attorney Harding stated the council has taken all action as required by the city codes to inform the owner. The owner has signed for all certified letters sent but has taken no action, did not show up for the hearing and has not been in contact with the city since December 2023. The parcel report indicates the house was built in 1955, the detached garage is 1794 sq. ft., and the house sits on a 645 sq. ft. basement.
