The La Cygne City Council met on Monday, January 2, 2023 at the La Cygne Community Building. Council Members present were: Thomas Capp; Jerome Mitzner; Danny Curtis; David Brenneman; and Keith Stoker.

CALL SPECIAL MEETING TO ORDER (6:00 P.M.)

The Purpose the Special Meeting was called for:

Cost of Living Adjustment (COLA) review, Pay Scale review, and employee performance evaluations.

The council members reviewed the current COLA rates issued by Civil Service Retirement System and the Federal Employment Retirement System. The past 5-years of COLA adjustments for the City of La Cygne were reviewed.

Discussion then reverted to the Employee Wage Scales which expired on December 31, 2022. Prior to establishing the new Employee Wage Scales, the Council proceeded with defining what will be the city employee positions for each department.

The Council recommended the following employee positions:

- Deputy City Clerk
- Police Chief
- Senior Police Officer

- Codes Enforcement Officer
- Public Works Superintendent

- Public Works Laborer 1
- Compactor Operator
- Cemetery Caretaker

Entry wage levels were discussed for surrounding areas and positions. CC Wade presented spreadsheets for each department depicting various pay levels and benefits to show what the budget estimates would be overall.

The council had a lengthy conversation on COLA adjustments, merit raises, and performance raises. The pay scales were reviewed and the council made a recommendation for the "new hire wage" for each established employee position for the City of La Cygne.

The council then took in to consideration the process for implementing the new pay scales. Several ideas were reviewed for how to transition the existing employees.
