# **REPORTS OF CITY OFFICERS:**

#### POLICE CHIEF ZACHARY MATHIES

Chief Mathies reported on the 2025 Totals for Traffic Stops (533), Citations (65), Calls for Service (425), District and Building Checks (339) and Reports (135). From August 21 – September: (4) Information Reports, (1) Alcohol Offenses, (0) Traffic Misd. Offense, (44) Traffic Warnings, (4) Criminal Offense Report, (1) Accident Reports, (1) Drug Offenses, (1) Warrant Arrests, (3) Traffic Citations, (24) Calls for Service; (1) Animal Citations; (41) UTV Reg. Total.

Chief Mathies will be attending CLI by FBI-LEEDA training in Topeka 9/08 – 9/12.

Interviews were performed for the Community Development Officer. An offer was accepted by Tori Philpot. Tori currently works in Gardner, KS as the codes officer and Animal Control Officer. She has resided in La Cygne for a year. Tori will begin employment on September 29, 2025 upon completion of preemployment screening.

Austin Jones resigned from the Part-time Police Officer position due to his schedule and commitment with the Anderson County K-9 unit. Chief Mathies thanked Austin for his time and dedication to the La Cygne department. An offer was provided to Cameron Patton who worked for the Prairie Village police department. Cameron will start in two weeks.

Chief Mathies has been developing and implementing a self-step Part-Time Officer FTO (Field Training Operations) program. The program mirrors the full-time officer FTO program with modifications to meet the limited time of part time officers on duty.

New street signs have been received and placed around town. "NO TRUCK" signs were placed on south 4<sup>th</sup> street to help prevent semi-trucks from encountering issues with the railroad crossing. Chief Mathies reviewed the intersections of Lincoln and 6<sup>th</sup> and Lincoln and 5<sup>th</sup>. The stop signs on 6<sup>th</sup> street at the intersection of 6<sup>th</sup> and Lincoln will be removed and the stop signs will be added on Lincoln at 5<sup>th</sup> and Lincoln. Traffic will stop on Lincoln Street but traffic will not stop traveling on 5<sup>th</sup> street or 6<sup>th</sup> street when crossing Lincoln. Notice will be posted with effective date of October 1, 2025.

# PUBLIC WORKS - DAN NASALROAD

PWS Nasalroad reported on the progress with the Water Plant maintenance. The engineer will be on-site next week to review the flash mixer in the weirs. The contractor is still waiting on the river pumps. The City of Linn Valley water connection project is still on schedule for September pressure testing of the line. Their bulk water fill unit has been received and will be installed. The pumphouse brick is completed. We are still waiting on the master meter for the interconnect.

The park mower right drive pump went out. Total repair cost \$3400. Mower is only 2-years old, mechanics had no explanation on reason for the pump to go out.

#### FIRE CHIEF - DAN NASALROAD

Fire Chief Nasalroad reported on a structure fire in town on N. 7<sup>th</sup> Street Court. Thanked Linn County Rural, AMR and La Cygne Police Department for their assistance.

#### CITY CLERK - JODI WADE

Cereal Malt Beverage (CMB) Licensing webinar was informative. The City of La Cygne needs to review the codes section regarding the CMB Licensing for any necessary updates. There is a bill on the floor of the Legislature to place CMB Licensing under the authority of the Division of Alcohol and Beverage Control. CC Wade will keep the council updated. All current CMB License holders have been informed of the changes.

Marais Des Cygnes Water Assurance District invoice was reviewed. CC Wade explained the capital improvement project being performed by the Corp of Engineers in 2027. The additional invoiced costs could be allocated over three years (2025/2026/2027). CC Wade pointed out the reserve fund the district is building to avoid increases in the future for capital improvement projects on the reservoir.
