a] 825 N. 7th Street Court (*Legal Description: Sweet Prairie Estates, Lot 1, Section 33, Township 19 Range 24*): The home was damaged by a structural fire in October 9, 2023. The property was placarded on October 11, 2023 per code 7-708(e) Compliance required before Re-occupancy. The property owner has also been cited for residing in a placarded structure; living in a Recreational Vehicle on the premise and non-compliant construction per the approved building permit. Andrea Kincaid attended the February 7, 2024 council meeting to present the status of construction and to discuss living in the recreational vehicles on the property. The Council proceeded with abatement process to include an Official Hearing in April 2024. (See Power Points)

b] 112 S. 7th Street (*Legal Description: First Addition La Cygne, Block 61, Lot 5-6, Section 04, Township 20 Range 24*): On December 7, 2022 an inspection of the property found the home and garage to be dilapidated. On January 26, 2023 the property owner stated he would have the house torn down and would seek contractors to perform the work. February 8, 2023 the Property owner confirmed he had contacted some contractors. January 31, 2024 the property owner has made no progress and has not followed up with the city.
